Summary of key findings for parents

This provision is good

- Children enjoy the time they spend at the club. Staff provide them with an abundance of sports, games and craft activities. This helps children to build on their physical, social and creative skills.
- The well-established, key person system promotes children's emotional well-being, and helps them to develop secure relationships with the club staff.
- Children understand and follow the rules of the club. They cooperate well with staff and show high levels of respect for each other and the environment.
- There are good arrangements to determine staff suitability. Robust recruitment and vetting procedures are followed, to ensure that staff are suitable for their roles.
- Staff foster children's personal development well. Children's positive behaviour and kindness are shared and celebrated, helping them to feel proud of their achievements.
- Although staff induction, supervision and training are good, leaders do not always check that staff fully understand their roles and responsibilities, to ensure they follow the club policies and procedures meticulously.
- Children do not have access to a cosy and comfortable space, where they can rest and relax during the day.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- continue to support staff, to help them to develop a comprehensive understanding of their roles and responsibilities
- review the organisation of the environment, to provide children with more opportunities to rest and relax comfortably if they need to.

Inspection activities

- The inspector viewed the areas of the premises used by children.
- The inspector spoke to staff and asked them questions to establish their understanding of how to safeguard children.
- The inspector completed a joint observation of an activity with the supervisor and discussed how she evaluates staff interactions with children.
- The inspector read feedback from parents and took their views into consideration.
- The inspector checked the suitability of staff, including evidence of qualifications and paediatric first-aid training.

Inspection findings

Effectiveness of leadership and management is good

The arrangements for safeguarding are effective. Staff ensure that children's safety is given good priority. The premises are safe and secure, and children are well supervised. Leaders ensure that staff have a secure understanding of the procedures to follow if they have any concerns about a child's welfare. Staff successfully help children to have a good understanding of how to keep themselves safe. For example, they remind them to wear sun hats and sun cream as it is very hot outdoors. The management team is dedicated and committed to their role. They use many methods to evaluate the provision. For instance, leaders regularly seek the views of parents and children, to enable them to provide age-appropriate resources that fully engage and capture all children's interests. Partnerships with parents are good. Staff exchange information with them daily, so that they are fully aware of children's activities. Leaders form good links with the school's children attend. This helps them to provide children with consistency in their care.

Quality of teaching, learning and assessment is good

Staff encourage children in their play and successfully support them to develop their skills further. For example, children play team games, such as badminton and cricket to help develop their physical skills. They interact well with others, concentrate and understand the need to take turns and share. Children become engrossed in creative activities, such as when they design and create picture frames. All children show confidence in speaking and listening. They demonstrate this when they talk about their family pets, holidays and other things that are important to them. Children enjoy looking at and reading books. Staff use these interests to extend their understanding, such as asking them what they can see and to predict what might happen next.

Personal development, behaviour and welfare are good

Children's behaviour is good. Most children settle quickly to play and concentrate well on their chosen activities. Staff are sensitive to their needs. For example, they respond promptly when children need extra reassurance and offer them suggestions on activities that they might enjoy. They are effective in teaching children to understand the importance of leading a healthy lifestyle. For example, they act as good role models, and talk to children about eating fresh fruits and drinking plenty of water. All children are encouraged to be physically active. For instance, through the many sports activities and using apparatus in the large outdoor area.

Hawkedon Primary Funtastic Kids is located at Hawkedon Primary School, Lower Earley, Reading in Berkshire. It registered in 2017 and is privately run. The club operates Monday to Friday during holiday times only, from 8am until 6pm. The provision employs six staff. The director and one other member of staff hold a qualified teaching degree, and one other member of staff is qualified to a level 3.
